RASCW New Member Billing

- REALTOR® & Affiliate dues for new agents will be **pro-rated monthly** and **collected at time of application approval**.

 - Please note that dues are non-refundable.

RASCW Annual Billing

- REALTOR® & Affiliate dues are invoiced **annually**, and **sent via email** directly to each agent/affiliate member
 - Click [HERE](#) for the dues schedule
 - Please note that dues are non-refundable.
- Invoices are sent in **October**, with a due date of **December 1st**.
 - If opted into autopay, autopayments will be run on **December 1st**
 - Go to your HomeBase account [HERE](#) to verify if you have opted into autopay.
- A **\$100.00 late fee** will be assessed on **December 15th** for any unpaid invoices.
- **RASCW & MLS services will be suspended on December 30th** for agents/affiliates who have unpaid dues.
 - Reinstatements will be assessed a **\$50 reinstatement fee**. In addition to the **\$100 late fee**

MLS New Member Billing

- MLS dues for new agents/appraisers will be **pro-rated monthly** and **collected at time of application approval**. Supra eKey dues for new agents/appraisers will be **pro-rated quarterly** and **collected at time of application approval**.

MLS Annual Billing

- MLS dues and Supra eKey dues are invoiced **annually**, and **sent via email** directly to each agent/appraiser.
 - *Rock-Green and Central MLS users are not billed annually, unless they were opted in to SCWMLS services*
 - Please note that dues are non-refundable.
- Invoices are sent **mid-May**, with a **due date of June 15**, for the service period of **July 1 – June 30**.
 - If opted into autopay, autopayments will be run on **June 10th**
- **A \$50.00 Late Fee** will be assessed on **June 16th** for MLS unpaid invoices.
- **A \$50.00 Late Fee** will be assessed on **June 16th** for Supra eKey unpaid invoices.
- **MLS services will be suspended for agents/appraisers who have not paid by the last business day in June.**
 - **The late fee will remain on the invoice if reinstated.**

The Participant Member* agrees to report to the MLS **all agents licensed with them**, and **all licensed/certified appraisers affiliated with them**, as well as any termination of affiliation within 30 days of addition or termination.

The Participant is responsible for all MLS dues and fees for themselves, their firm, agents licensed with them, and licensed/certified appraisers affiliated with them.

Participants will receive a list of their unpaid agents/appraisers by June 15.

**Participant Member refers to the Broker or licensed/certified Appraiser who is the member of the MLS.*

IDX/BBO/VOW Quarterly Billing

For those who have an IDX feed, BBO, or VOW set up:

- IDX/BBO/VOW dues are invoiced **quarterly**, and **sent via email** directly to each agent/broker where applicable
 - **Invoices will be sent via email on 1/1, 4/1, 7/1, and 10/1.**
 - **Please note that dues are non-refundable.**

Overdue Invoice Policy:

- **A \$50.00 late fee will be assessed for any invoices that are 30+ days past due**
- Any invoices that are **overdue by 60+ days** will result in the **suspension** of your IDX feed and your MLS services.
- Any invoices that are **overdue by 90+ days** will have their memberships to RASCW/SCWMLS **dropped entirely**.

- South Central WI MLS IDX ----- \$100 set up and \$20/quarter
- South Central WI MLS VOW ----- \$100 set up and \$50/quarter
- South Central WI MLS Broker Back Office ---- \$100 set up and \$50*/quarter
- WIREX IDX or VOW ----- \$199 set up and \$50/quarter
- WIREX Broker Back Office ----- \$199 set up and \$250/quarter

Agent website or data use:

- South Central WI MLS IDX or VOW ----- \$100 set up and \$50/quarter

MLS Monthly Billing

This is not for MLS users, MLS access is billed annually.

Invoices for Vendors will be sent via email on the first week of each month.

- **IDX Vendors** that are utilizing a **Web API data feed** for the MLS are subject to a **\$60 monthly fee** that will be billed via invoice sent to the email we have on file.
 - If the email on file needs to be updated, please contact member@wisre.com
 - **Please note that dues are non-refundable.**

- The Rock-Green Association will be billed directly for each Rock-Green MLS Agent and Broker utilizing Paragon. Invoices are sent via email.
- The Central Wisconsin Association will be billed directly for each CWMLS Agent and Broker utilizing Paragon. Invoices are sent via email.

Overdue Invoice Policy:

- **A \$50.00 late fee will be assessed for any invoices that are 30+ days past due**
- Any invoices that are **overdue by 60+ days** will result in the **suspension** of MLS services.

MLS Compliance

Please refer to our [Summary of MLS Listing Rules](#) and [Summary of MLS Fines](#) for guidance.

The following is our compliance procedure:

- An agent who has violated one of the MLS Listing Rules will first receive a notice email detailing the violation, how to correct (if applicable), and how to appeal.
 - **Please read these notices carefully as they contain important information.**
- Appeals will be accepted **up to 30 days after first notice**.
 - **To Appeal:** Reply All to the notice email with your appeal, or email listings@wisre.com
- Invoices for violations will be sent 2 business days after the first notice.
- **A \$50.00 late fee will be assessed for any invoices that are 30+ days past due**
- Any invoices that are **overdue by 60+ days** will result in the **suspension** of your MLS services.
- Any invoices that are **overdue by 90+ days** will have their memberships to RASCW/SCWMLS **dropped entirely**.

Checks

Any check returned by the bank due to insufficient funds, a stop payment, or a closed account will be assessed a \$50 returned check fee.
